Chamber Music Scotland is actively seeking new trustees to join our Board.

CMS has an appetite for change and growth, and we are looking for a board member who can help us thrive over the coming years, particularly as we prepare to make our next application to Creative Scotland for multi-year funding. Your contributions will positively impact CMS and the musicians, creatives, and communities with whom we connect across the length and breadth of Scotland.

We are particularly interested in candidates with experience in income generation for social enterprises, and/or experience delivering international arts projects. However, we really want to bring in the best people to support our organisation, so if you don't have these particular skills but believe you can make a difference at CMS, then we would encourage you to apply. We also welcome applications from people who may not have previous board experience, as we offer training and development opportunities to all board members of our organisation. It is not necessary that applicants be based in Scotland.

This post is voluntary, with no remuneration. However, reasonable travel expenses will be covered. The Board of Trustees meets four times a year, with three meetings taking place online and one taking place in person at our office in Glasgow.

The new Trustees will join Chamber Music Scotland at an exciting time, as we continue to develop the organisation, embracing new ideas and new ways of supporting the people we work with, whilst developing chamber music in Scotland. You will be responsible for governance and act as an ambassador for both the organisation and the wider chamber music sector in Scotland.
